
#### **GREETINGS FROM PRESIDENT MARK**

For those who weren't able to attend our last Guild general membership meeting--another great one with Bunny Gillespie giving her penultimate history of Daly City--I briefed everyone on the Guild's Daly City Centennial Documentary Project. The Guild is collaborating with KM2 Communications of South San Francisco to make a documentary of Daly City in this, its centennial year. The Guild's historical archive would provide a key source of historical material. Kevin Mullin and Bryan Kingston are award-winning documentarists who have created similar DVDs on the closure of the Bay Meadows Race Track, South San Francisco, Daly City Police Athletic League [PAL] 50th Anniversary, and more. They have offered to lead the fundraising effort in conjunction with a Guild committee to secure grants to make this project possible as a Guild sponsored production. If successful in this endeavor, we will have a professionally-produced feature DVD that will tell the history of the Daly City community from just before its origins to present-day. We have set a goal of raising \$50,000, which would be the cost for KM2 to produce roughly a 30-minute documentary film. I know that we all are keeping our fingers and toes crossed that this endeavor proves fruitful. The Guild then would sell copies of the DVD with all proceeds benefiting our organization. Stay tuned for future updates.

#### **Oral History Tapes and Historical Video/DVDs**

# CENTENNIAL MEMORIES

The weeks between March, 1911, and May, 1911, were highly

productive, challenging, and memorable for officials and residents of San Mateo County's newest municipality. Daly City announced to the world that it was an entity to be acknowledged.

In less than a month after Daly City's successful election in mid-March to incorporate, adopt a name, elect Trustees, and designate other civic officials, the important, but sometimes seemingly mundane, business of running the City was launched in orderly manner. The area's new identity was being readily accepted and publicized. Immediately following the March 22 "birthday" of Daly City, J. L. Brown, proprietor and editor of the local weekly newspaper, changed the name of his publication from the Colma Record to the Daly City Record. Newly uniformed through the generosity of the affectionately known "Father of Daly City", John D. Daly, local baseball players proudly sported "Daly City" across the front of their team shirts. The Grandview Band renamed itself the Daly City Band and the Progressive Socialist Club of Vista Grande placed the name "Daly City" on its banner. Local businesses ranging from restaurants to grocery stores provided location information specifying "Daly City" in their advertisements. "Biggio's Restaurant" became the "Daly City House".

A request was made to United Railroads that destination signs on their electric streetcars indicate the rattling of passengers to "Daly City", rather than "Daly's Hill". The request was quickly granted. A modest "Daly City" sign just south of the San Francisco-San Mateo county line was nailed onto a wood post that would be visible to passengers aboard passing railroad trains.

Meanwhile, in a small multi-use wood frame building at 612 Mission Road, south of Daly's Hill, the newlyelected Daly City Board of Trustees gathered with friends, foes, family, political hopefuls, and local gawkers for their official swearing-in as leaders of the new municipality. Within the building, "Judge" Ellis C. Johnson, a San Mateo County Notary Public, administered their oaths in a room designated as the "Justice's Court" room. The building, still in use in 2011, is now identified as 6626 Mission Street. This building had served as the seat of local justice (San Mateo County, Township One) for a number of years, as well as the residence of Judge and Mrs. Margenette A. Johnson. In 1911 the building achieved another distinction when it was selected for use as Daly City's ad hoc "City Hall". To date the aging, unimposing, and unique storefront building remains an officially unmarked location of significant historical interest near the Top-of-the-Hill in the neighborhood known as Original Daly City. A more imposing governmental headquarters would be constructed in 1913.

After all the new officers "subscribed to the Constitutional oath" before the Judge, Trustee Dennis Quillinan was elected Chairman pro- tem of the Board until Edward J. Freyer took over as the first holder of the Mayoral gavel.

According to the Daly City Record, the first matter of gravity to challenge the Board was the determination of a location in which Trustees could conduct official sessions. Several earlier ad-hoc meetings had been held in various sites, including local stores. Not all Daly City voters totally approved of those earliest venues. At least one meeting had convened in a private residence, generating criticism from citizens that accused the newly elected quintet of exclusivity. The 1911 vocal electorate, who might be considered the forerunners of 2011's brigade of city hall watchers, also spoke out regarding lack of accommodations for the viewing public, and hinted overtly about reportedly clandestine activities.

Ordinance #1 fixed the meeting place of the Board of Trustees and times for holding regular meetings. The ground-breaking electees voted that all regular Board meetings would be held at 8 p.m. each Monday at 612 Mission Road. Ordinance #2 regulated the bonding of officers: \$500 for Poundmaster; \$2000 for City Marshal Fred T. Hopper; \$4000 each for City Clerk William J. White and City Treasurer Timothy Sheehan. Ordinance #3 addressed the selling, disposing of, or giving away of any spirituous, malt, or fermented liquor or wine, or any mixture thereof without a liquor or saloon license. Ordinance #4 addressed establishment of streets, sidewalks, alleys, squares, and parks. Regulations within this Ordinance also oversaw traveling merchants, peddlers, and riding on sidewalks in all vehicles except baby carriages and invalid chairs. Ordinance #5 provided for the design and character of the Official Seal for Daly City. The seal, which the City Clerk was directed "to procure, keep, and use," was to "consist as impressed of a circle having on its face and within its circumference the following in substance and effect: DALY CITY, Incorporated Mar. 22, 1911, San Mateo Co., Cal." F. B. Woodhouse, who had run unsuccessfully for the office of Trustee in March, achieved a moment of fame by being the first person to make application for a dog license after passage of Daly City's official animal Ordinance #6. Frank Woodhouse would go on to greater recognition from 1916 to 1918 by becoming Daly City's third Mayor.

In months to follow, additional official acts and Ordinances would be pondered and passed by the Board of Trustees. Their first appointment was the naming of James J. "Duck" Sullivan to serve as pound master. Ordinance #13, adopted in April, 1911, established that neither animals nor vehicles could be ridden, driven, run, or operated faster than five miles an hour near public schools or the Top of the Hill, and no faster than ten miles per hour elsewhere in Daly City. To date, according to the 2011 City Clerk Annette Hipona, Daly City has enacted 1354 Ordinances. K&BG

In addition to being elected a Daly City Trustee (City Council Member) in 1911, he was involved in local Republican party politics and was appointed as a Fire Commissioner in 1910 for the Volunteer Fire Department.

# IN MEMORY OF A GUILD FRIEND

Longtime Guild member **John Olcese** passed away March 29, 2011 at the age of 80. He was the grandson of Francesco and Maria Olcese who emigrated from Liguria Italy in the late 1800's and settled in Colma where they raised vegetables. John and Assunta Olcese, John's parents, started in the flower industry in 1946, raising sweet peas and later fuchsias, geraniums, and daisies.

John graduated from Jefferson High School where he was Senior Class President and Captain of the baseball team. He later attended the University of San Francisco as a member of the USF baseball team. He was lifelong avid sports fan, especially for the San Francisco Forty Niners, and as a member of the Old Timers Baseball Association.

John joined in his parents business after finishing his service in the U.S. Army and continued to operate John's Nursery, one of the oldest wholesale nursery businesses in the area specializing in perennials and annuals, until his passing.

John was a long time member of the Guild who will be remembered as a member of a pioneer family, for his beautiful fields of flowers in Daly City, and his generous donations of flowers for Guild raffles and landscaping in front of our museum.

*Colma Record*, March 17 1911 - Wednesday morning another villainous outrage was perpetrated in Vista Grande by a teamster... who deliberately drove a heavy truck loaded with flour for over half a block on the side-walk on Melrose Street, north of Theta Avenue, damaging the walk fully \$50 and then across the corner at Melrose and Vista Avenue, breaking the walk there. Do we need incorporation? authors include Little Boxes [Westlake], by Rob Keil [\$38.25]; Great Daly City Trivia Book, by Bunny Gillespie [\$16.50]; author and Guild Member Bernie Winn has four of his books in our shop: From "The Top Of The Hill" [\$20]; California Drawbridges [\$19]; San Francisco Underfoot [\$38.25]; and Railway Adventures (Europe) [\$10]. These titles are all out of print. Also, we stock Crab is King, by Bernard Averbuch [\$5.50]; and finally, Daly City Fire Department Centennial, 1907-2007 [\$5.50]. All of these books are available for purchase at the gift shop.
