FROM MARY'S HELP TO SETON MEDICAL CENTER

When good member Stan Roderick was in Seton Hospital recently, he had a lot of time to ponder many things. One thought was that of having the hospital's history as a topic for our History Guild.

The administrators were contacted by Program Chair Bunny Gillespie, and the result will be the presence at our upcoming September 18th Guild meeting of Sister Florence Urbine, chairperson of the Board of Directors of Seton Medical Center, 7:30 p.m., Doelger Center.

Sister Florence will be joined in a two-part history of the hospital by Marie Mahoney, Assistant to the President and CEO, a veteran of 55 years in the nursing profession.


Ms. Mahoney is the author of a beautiful book "Reflections on Mary's Help Hospital and Seton Medical Center." She will present the history of the hospital, from its inception in 1893 in San Francisco to its 1965 move to Nanny Goat Hill in Daly City.

The more recent history of Mary's Help, and now Seton Medical Center will be related by Sister Florence.

Many of our members have held volunteer positions at the hospital over the years, and many have been patients in the imposing 10-story building over-looking most of Daly City and Colma. Members are invited to bring pictures, mementoes, etc. for the display table at the September 18th meeting.

GATES & GARDENS A DELIGHT

On May 15th last, members and friends were treated to a splendid show presented by Betty Horn, of the San Mateo County Historical Association, entitled Gates and Gardens of the Peninsula.



A wide range of estate gardens and their imposing gates was shown, highlighted by the 600 acre Filoli. An enthusiastic photographer, Betty has preserved for viewing many of the beautiful sites which have since disappeared. Prior to her showing, several slides of the Meussdorffer mansion were displayed. The square block estate, used as a summer residence by the San Francisco hat manufacturer, was a showplace since the 1880's, until it was destroyed by fire in 1960. Its site is now occupied by the George Washington Elementary School in Daly City.

Exhibit tables were presided over by Ted Babow, raffle tickets sold by Walt and Elaine Riney. The prize of a beautiful chrysanthemum was won by Aida Larsen. Refreshments, under the fine management of Mary Hutchings, were dispensed. Many thanks to Marilyn Olcese, Bob & Enid Williams for their genial behind-the-counter activities, and to goodie donors Gwen Newman, Anita Stagnaro, Esther Appleton, Chuck Meagher and Anne Ingersol. VICTORIAN DAYS

Hopefully this bulletin will be received in time to remind members of VICTORIAN DAYS IN THE PARK, held in San Mateo's Central Park on the weekend of August 24-25.

Always a very pleasant event, the two-day arts and crafts fair will feature two activities of interest. At 3:00 p.m., Saturday, August 24th, there will be a CIVIL WAR WEDDING, a real, honest-to-goodness ceremony on stage in full period dress, the groom in Civil War uniform, the bride in a lovely, hoop-skirted wedding dress. A cross-

sabre honor guard will form a processional arch for the couple, who will be married by Judge Jose deLarios, past president of the San Mateo County Historical Association.

The second event will be the recreation of the BRODERICK/TERRY DUEL, the duel which many say sounded the first shot of the Civil War, and certainly the end of dueling as a mode of settling differences. Last year the duel was recreated at its actual site, in the little park in Daly City near the County line.

On stage to portray the antagonists will be Geno Fambrini (Terry), and Richard Hill (Broderick), both members of our Guild. Narrating will be a team of commentators, Dr. Robert Chandler, history officer of the Wells Fargo Bank, and Ken Gillespie, doubling in brass as the m.c. for the entertainment during the weekend. The duel will be at 12:00 noon, Sunday, August 25th!

Our Guild will have its place on History Lane, along with 16 other history-related organizations. We will have displays of photographs, Guild information, stationery and Trivia books for sale. Come on by and get a spritz of "Official Daly City Air", which we bottle and spray for cooling effect on passers-by...always good for a laugh!


